### **Course Description**

**3 Class Hours -0 Laboratory Hours -3 Credit Hours**

The course will examine law enforcement response to domestic and international terrorism. Topics will include threat analysis, intelligence processing, proactive measures, reactive measures, development of modern terrorism and specific terrorist groups.

### **Course Objectives**

1. Articulate what terrorism is and how to combat it.
2. Learning how to learn-become a better student.
3. Caring: developing new feelings, interests, and values.
4. Human dimension: learning about yourself and others.
5. Explain why it is important to study and comprehend terrorism.
6. Discover why normal people become "radicalized" and become driven to conduct horrible acts against humanity.
7. Analyze the various types of terrorist groups, their threats to society, and their motivation to act.
8. Propose original solutions to advise homeland security officials regarding methods and activities to deter future terroristic ideations.
9. Determine the basic root causes of terrorism.
10. Identify the current terrorist threats to the United States.
11. Demonstrate an understanding of international and domestic terrorism groups; their methodology; their behavioral analysis; their techniques, tactics, procedures and their objectives.
12. Identify the financing, costs, and equipment needs of terrorist groups.
13. Identify intelligence-gathering and counter-intelligence techniques for terrorist groups.
14. Describe the future endeavors and expectations of terrorist groups.

15. Prepare a case study with a threat analysis of a terrorist group and present findings to peers.

**Course Requirements & Grading**

Students complete two examinations and prepare a research/writing requirement.

**Research/Writing Requirement with Presentation:** Students prepare a case study with threat analysis on an assigned terrorist group. The paper will be **1500 (minimum) and 2500 (maximum) words**. Each student prepares and presents a 10-minute briefing on their research.

**Exam Make-Up Policy-** If you will miss an exam, let me know in advance. I will work with you to complete the requirement. You must complete a make-up exam within one week of the scheduled date of the exam.

**Weather-** If the weather prevents us from meeting, follow the schedule and continue your reading and research. Check the KSU Web-Page and listen to local radio. **Research/Writing Requirement with Presentation**

Your learning goal for this paper is to demonstrate empirically the knowledge set forth in the learning objectives. Your research/writing requirement is a threat assessment of an assigned terrorist group. Use the **APA writing style** and a **minimum of four** references: two academic, scholarly sources (**not** periodicals like Newsweek, Time, etc.) and two additional credible media sources. Wikipedia is not a trusted source as anyone may post; however, their list of books and references may provide direction and ideas. Use a 12-point font. Papers will be submitted to “Turnitin” for grading. No paper copy is required.

**The KSU Writing Center helps students in all disciplines and at all levels of ability improve their written work. Experienced, friendly writing assistants work with you on topic development, revision, research, documentation, grammar, and more. **Research Guide: your paper will include:** the history, the goals/ideology, the mission(s) and events, the victims, the movement (growth/decline), the financing, and the future of the group. Include in the threat assessment: capability and probability factors, violence potential, weapons gathering/damage potential, cellular structure, training, target identification methods, vulnerabilities, and consequences of intervention. A complete rubric is at D2L under “Research Paper”.

**Paper Evaluations are scored based on:**

1. Quality of research
2. Organization & adherence to the research guide-address all subtopics
3. Quality of presentation and writing
4. Submitted on time!

**A detailed scoring rubric is posted on D2L.**

Research papers for CrJu 3400 must be submitted to [www.turnitin.com](http://www.turnitin.com) to determine originality and prevent plagiarism. Papers will not be accepted unless evaluated by the professor in Turnitin.

Originality Report. The Originality Report (OR) provides a summary of matching or highly similar text found in a submitted paper. If quoted or bibliographic information is found in the paper to be similar or matching another source, it can be removed from the OR. Plagiarism is determined by the professor.

***Papers must be submitted on turnitin.com. No hard-copy of the paper is required.***

Students are encouraged to use the video tutorials found at the turnitin website. Enroll as soon as possible but not later than September 1st.

### **Class Activities**

Class time is devoted to discussion, lecture, case studies, and reviews. Guest lecturers and films are a part of this course and information presented is testable. Changing circumstances may lead to adjustments in course assignments and scheduling.

Laptop Computers are NOT allowed in the classroom unless you have a documented learning disability! ALL BlueTooth devices must be removed. Cell phones must be placed on silent or off. No texting during class; if you do, you will be asked to leave.

### **Class Participation**

Class participation is very important. You will be expected to research Chapter questions and prepared to discuss these in class. Your class participation grade will be determined by:

1. Class Attendance
2. Preparation to discuss the lesson and Chapter questions from the book as evidenced by engaging in class discussion.
3. Participation in the research paper presentation.

Quality class participation is characterized by the following:

- Offering a different and unique but relevant perspective;

- Contributes to moving the discussion and analysis forward;
- Builds on other comments;
- Transcends the “I feel” syndrome...i.e. it includes some evidence, argumentation, or recognition of inherent tradeoffs.
- The comment demonstrates reflective thinking.
- Disagreement is ok, just be able to explain your viewpoint.

**Unofficial Withdrawals- Last Date of Attendance:**

A “W” or “WF” grade will be submitted for students who stop attending class and do not officially withdraw as follows:

For students who stop attending class on or before the published “Last Day to Withdraw without Academic Penalty date, a grade of W or WF should be assigned based on the student’s status in the course.
