What you must do to succeed in this class:

- Have good self-discipline and good time management. Forgetting to do an exam or being in a place that has no Internet accessibility does not warrant for a make-up.
- Due to the nature of web-based courses, all communications and participation in this course (including completing and submitting the examinations) will be done online. However, students also can make an appointment to meet the instructor to discuss their concerns about the course. It is important that students understand all of the course requirements.
- Follow the instructions strictly, especially the discussion and term paper.
- Go to the course web site to check the Announcements and Email regularly (maybe at least twice a week) to see whether there are any new messages. Course Description:

This course will introduce you to the criminal justice system (both adult and juvenile). We will examine the main goals, organizational structures, and occupational roles associated with the police, the criminal courts, and corrections. We will learn about how accused persons are moved step-by-step through the criminal justice system. We will also address controversies related to public policy on crime control.

Course Objectives: Upon successful completion of this course, students should be able to:

- Demonstrate an understanding of the goals of the criminal justice system
- Discuss the causes of crime and apply criminological theories to crime
- Describe the agencies and their functions involved in the criminal justice process
- Discuss special topics in criminal justice
- Demonstrate an understanding of the juvenile justice system
- Discuss global issues in criminal justice

Course Requirements:

- Text: George Cole and Christopher Smith's Criminal Justice in America, 5 Ed., 2008.
- Internet access for weekly assignments, quizzes and discussion online.
- Regular and punctual attendance is expected.
- You are responsible for all materials, including reading assignments.

Evaluation: Your grade will be based on the following:

- 10% Web Discussions
- 20% Chapter Quizzes
- 30% Exams
- 20% Assignments
- 20% Courtroom Observation Paper
- 100%

Final grades will be determined based upon the following scale:

There is no extra-work policy in this course.

Five Course Requirements:

1) Discussions

Students are required to post weekly to our GeorgiaView Vista discussion board on topics posted. Students are also required to respond to another student's posting each week. Thus, a total of 2 separate postings are required. **Late postings will not be graded, and students will earn no credit for that weekly discussion.** Postings will be graded based on academic relevance and must display some analytical ability. The average of your discussion grades will account for 10% of your final grade in the course. To earn a high score for discussions, please refer to the grading criteria for discussions on the homepage.

2) Chapter Quizzes

Chapter Quizzes will be posted on the Vista site. The quiz is due on the date listed in course schedule. You will be required to complete 14 quizzes. **Late assignments will not be accepted, and students will earn no credit for that particular quiz.** The average of your quiz grades will account for 20% of your final grade in

the course.

3) Exams

Four exams will be given during the semester. Each exam is worth 100 points. Your exams will consist of fill-in-the-blank and short essay questions. Exams will be given online with a time limit of 2 hours from start to finish. Each exam will be available for you for three days. The due date of the exam is listed on the Course Calendar (below). No makeup exams will be given. The average of your exam grades will account for 30% of your final grade in the course.

Tips for answering the short essay questions: (1) write in a complete sentence; (2) address all the sub-questions asked; (3) define all the key terms in the question before discussing the details; and (4) provide enough supporting information.

4) Assignments

Research assignments will be posted on topics related to each chapter. These assignments will require some outside research (typically using the Internet). Typical assignments include 1 or 2 questions. Answers should be typed up in a Word document and will be about one page (usually 2-3 paragraphs). Each assignment is worth 100 points. **Ten points will be deducted per calendar day for late assignments.** The average of your assignments will account for 20% of your final grade in the course. To earn a high score for assignments, please refer to the grading criteria for assignments on the homepage. You must include a COMPLETE REFERENCE at the end of your answer (including the author's name, year, article's title, date retrieved, and website address.

5) Courtroom Observation Paper

You will be required to complete a courtroom observation paper. Your courtroom observation should be a minimum of two hours of observing an active courtroom. Detailed instructions are available on our homepage under "Courtroom Observation Paper." This paper is worth 100 points and accounts for 20% of your final grade in the course. **Ten points will be deducted per calendar day for late papers.** Your paper is due by **April 1.**

Note: For each of the five module discussion questions, you must post your main answer to the discussion question by the second day of that module period. The dates for each module period are shown in the second column of the course calendar table at the end of this course syllabus. For example, the dates for Module 2 are between June 4 and June 6, so the second day of this module period is Tuesday, June 5th. The second day of Modules 5, 9, 11, and 13 will be June 15, June 29, July 6, and July 13, in that order.

For the responding posting, you must post your meaningful response to one of the main postings by the last day of that Module period (i.e., Wednesday or Saturday). For example, the last day for Week/Module 2 is Wednesday, June 6.
